



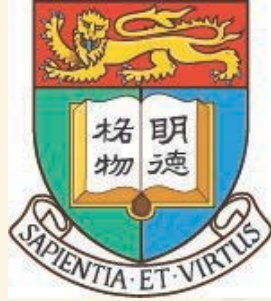

Why HK?

Why Dual Degree in Law with PKU?

- PKU is one of the premier law schools in China and a highly-ranked globally
- First dual degree in China
- Graduate with two law degrees:
 - HKU LLB (common law jurisdiction); and
 - PKU LLB (civil law jurisdiction)
- Open a door to qualify as a legal profession in both HK and China



- ▶ 5-year dual LLB degree programme
- ▶ Intake quota: **approx. 8 places** for each institution
- ▶ Medium of teaching: **English** (HKU) and **Putonghua** (PKU)
- ▶ First two and half years at the home institution and the following two and half years at the host institution
- ▶ Total no. of credits of the 5-Yr curriculum: **300 credits**
- ▶ Require to **complete 174 HKU credits** during period of study **at HKU**;
- ▶ Require to complete **no less than 96 PKU credits** during the period of study **at PKU**
- ▶ Obtain an LLB degree from respective institutions
 - i.e. **HKU LLB (common law jurisdiction)**; **and PKU LLB (civil law jurisdiction)**
- ▶ Eligible for admission to PCLL programme subject to application
- ▶ Pay tuition fee to respective host institutions

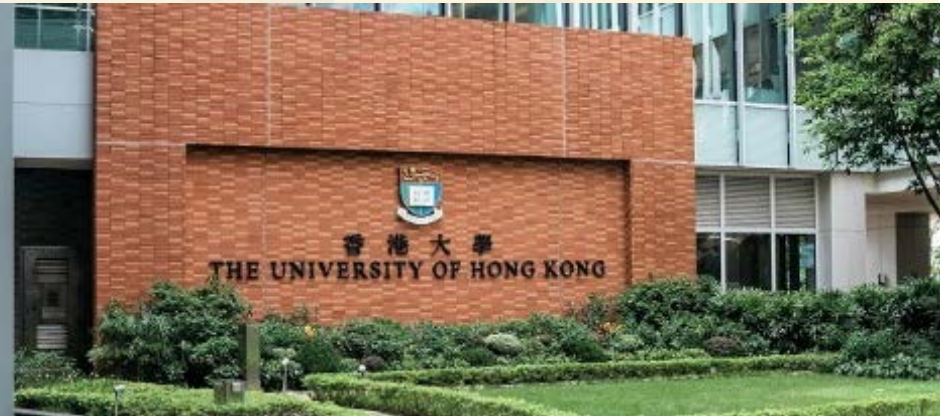


JUPAS Applicants

- Minimum
 - English 5
 - Chinese* 4
 - Math 3
 - Liberal Studies 3
 - 2 electives 3
- Band A choice in JUPAS application → FIRST choice
(*HKDSE: when you re-prioritize, put us as FIRST choice*)
- Interviews (for shortlisted candidates in late Mar or early Apr 2022)
- Tie-breakers: extra electives
- No penalty for repeaters (results must be within 2 years)

Proficiency in mandarin in writing, speaking and listening a must



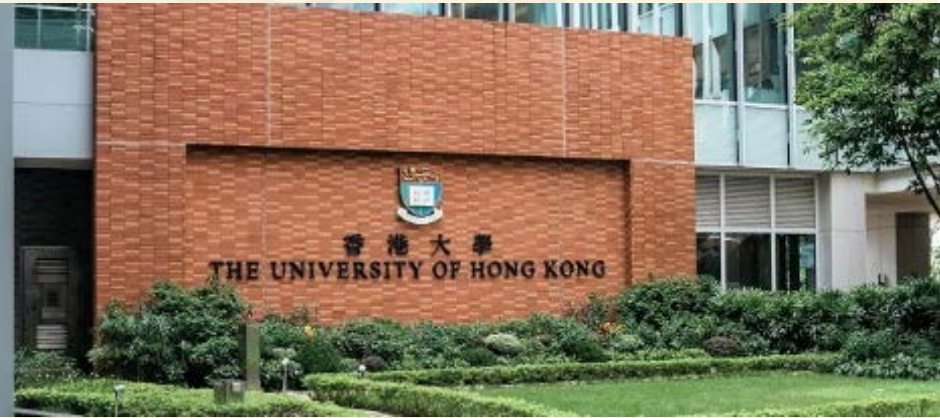
Non-JUPAS applicants



- GCEA Level (excluding English and Chinese):
at least **1A*** and **3A** (with 4 A-level subjects)
or **2A*** and **1A** (with 3 A-level subjects)
- IB: at least **37/42** or **40/45**
- Other qualifications: refer to UER for minimum requirements
- * ***Must complete senior high schooling in Hong Kong.***

Application Process

HKU-PKU Dual Degree in Law



- ▶ **Via JUPAS and non-JUPAS application system**
- ▶ Mainland applicants applying on the strength of GaoKao – via PKU Law Faculty online application system
- ▶ Hong Kong applicants* applying on the strength of HKDSE or other recognised examinations other than GaoKao – via JUPAS and non-JUPAS respectively
- ▶ **JUPAS applicants*** should also apply separately through the Faculty of Law online application system at <http://www.law.hku.hk/hkupku/>

Application Process

HKU-PKU Dual Degree in Law



** Special notes on eligibility of applicants:*

- ❖ Must hold a valid Mainland Travel Permit for Hong Kong and Macau Residents (Home Return Permit) and are not a student from Macau.
- ❖ **Must complete senior high schooling in Hong Kong.**
- ❖ *Highly proficient in both spoken and written Chinese (Putonghua) and English is a must.*
- ❖ *Place HKU LLB programme as one of your Band A choices (for JUPAS) or as the first choice (for Non-JUPAS) via JUPAS or non-JUPAS application system respectively in order to be considered in main round admissions.*
- ❖ Shortlisted candidates may be invited for interview by the Panel comprising HKU Law and PKU Law members.
- ❖ *Deadline for Faculty online application: **31 January 2022***

JUPAS admissions requirements:

M1/M2 is recognised.

1st Senior Secondary
Elective Subject (Category A)

Level 3

2nd Senior Secondary Elective
Subject (Category A) or
Mathematics Extended Part
(Module 1 or 2) / Other Language
Subject (Category C)

Level 3 / Grade E

The result of the Mathematics Extended Part (Module 1 and 2) is recognised as equivalent to that of a full elective in fulfilling the University Entrance Requirement **on the condition that one of the elective subjects must be a Senior Secondary Subject (i.e. Category A Subject).**
